Executive Summary

In continuation to the efforts and work of members of the administrative body and staff working in Baghdad Women Association and their continuous development of the work methodology in line with the requirements and needs of society in general and women in particular, which is the way that leads it to provide services to the target groups in the right direction, and to complement the efforts made by Baghdad Women Association work team with the support And the supervision of the administration of the association, during the year 2020, it had great luck in implementing humanitarian projects that helped and achieved an actual service for women and girls and society in general. The most prominent of these services is the provision of psychological / social and legal support and counselling to women and girls and building their cognitive capacities and skills, especially that target groups were characterized by diversity and not limited to a specific group or component, as it included refugee and displaced girls and from the host community, as well as males as an essential element to reduce violence against women and in order to gain their support as advocates for the issues of involving women in the decision-making and leadership process, in addition to providing health support by distributing dignity kits that contain health kits simultaneously with the Covid-19 crisis, the association has implemented many awareness health campaigns that included directives and instructions on correct practices and prevention of the virus and its effects, in addition to issuing awareness brochures in this regard and related documentaries.

The association work team within multiple projects, has presented and continues to present a procedural sequence interconnected with









implementation, monitoring and evaluation, and a performance that applies to the reality of the association's work, formulating its successes and overcoming its failures in all transparency. The methodology used in the implementation was also characterized by the involvement of the community, its institutions, governmental bodies and non-governmental bodies, and in cooperation with volunteers from the communities that receive the same services. The association through its programs and psychological, social and legal listening and counselling centres, was able to provide guidance that aims to solve the problems and challenges faced by women and girls and to develop a realistic vision of possible solutions within the goals and programs of the association, its specialized staff and capabilities, and in accordance with its vision and mission, 1,559,891 people from the community obtained the services of the association Among them, 783,170 are women and 776,721 are men.

Baghdad Women Association is a distinguished humanitarian organization that works in difficult conditions in different geographical areas, especially we live in Iraq under unstable political conditions and situations, it strives to expand its humanitarian mission and provide new and diverse humanitarian services to vulnerable groups.

Baghdad Women Association has been concerned with providing humanitarian services since its establishment in 2004, and this is what has earned it a distinguished position and a good reputation in the Iraqi community by providing high-quality and comprehensive services in its humanitarian interventions, such as providing a wide range of psychological, social, legal, health and cultural support, in addition to spreading human values and fundamental principles that comply with international law and conventions.






Services provided by Baghdad Women Association in 2020

Development and capacity building

Training and building the capacity of the staff has been an important pillar of Baghdad Women Association for a long time, but in 2020 it focused on adopting new methodologies and tools that fit the changes that occurred due to the pandemic, especially since the association continued to implement its projects and work without stopping, so the association adopted development methodology on remote learning mechanism, remote implementation and management, as well as remote monitoring and evaluation, and measurement of results and impact, and this was a new turning point in the work that added a lot to us.





Integrated security course / Baghdad Women Association

Women human rights defenders are ignorant that they have started implementing safety strategies, so it is important to support them to raise their awareness of safety strategies, which they have already started to apply and use instinctively to reduce risks to their security, and they should be guided to appropriate strategies to help them stay safe. It is important to assess the feeling of vulnerability, as women human rights defenders may not feel vulnerable or endangered by all the threats that have been listed. Rather, the function of the vulnerability analysis helps us to identify primary threats, especially those that pose a real danger to women human rights defenders, their colleagues, their peers, or even their families.

Tension is a natural and prevalent feeling on a human and global level. It is felt by everyone, but to varying degrees. Tension may be considered positive at times, but if it exceeds the normal limit or is not managed well, it has negative effects, knowing that tension and weakness have a positive proportional relationship that negatively affects security, so that those who suffer from severe stress or an increase in stress in their lives feel more vulnerable, and therefore may pose a threat to security, noting that the signs of stress and treatment methods vary according to the specificity of each individual case and its cultural background.

Baghdad Women Association has developed a plan to work with the female staff in the psychological / social and legal listening and counselling centres to hold the integrated security courses. The first course was carried out to the association's centre in Nineveh Governorate / Mosul, and we will continue to work with the rest of Baghdad Women Association centres in 2021.



The President of Baghdad Women Association, Ms. Liza Nissan Hido, implemented an integrated security workshop for the staff of the Psychosocial Listening and Counselling centre in Mosul at Fiori Hotel - Erbil as part of the self-care activity on October 24, 2020 within the project (Promoting the Well-being Dignity and safety of conflict affected SGBV Survivors) funded by Norwegian People's Aid.

The aim of the activity was to create a physically and psychologically safe space full of confidence, support and protection for women human rights defenders to share and explore safety and potential strategies for staying safe and healthy, and to allocate time to move away from the daily routine of work and an effort to take care of women for themselves as they do with others.







The mechanisms used to implement programs by the staff of Baghdad Women Association during the COVID-19 pandemic


During the period of the spread of the Covid 19 epidemic in 2020, especially with the instructions issued by the Iraqi Ministry of Health due to the increasing numbers of infections, which led to the closure of economic facilities, the end of gatherings, and the semi-suspension of life by imposing a health quarantine in homes, as this affected the mechanism of work of civil society organizations, especially that most of its activities are face-to-face and based on interaction with people.

The mechanism of Baghdad Women Association in responding to this matter was to develop a tight plan in the implementation of activities after studying it by project managers with the administration of Baghdad Women Association, which requires the implementation of project activities electronically and through social media platforms, especially the Skype & Zoom program. In the beginning, there were some difficulties related to the lack of knowledge in the use of these programs by those in charge of activities and also with women and girls due to their belonging to the simple groups in society, and this in turn took a lot of effort and time during implementation.

Therefore, a new and easier plan has been activated for participants, which is via the (WhatsApp) (Messenger) program, in response to the request of women and girls and their prior knowledge of the use of these programs.

The nature of the implementation was represented in sending the pre and posttests in all sessions to the participants and making a group to present the training material for the session or training through pictures and a detailed







explanation of each paragraph with receiving and responding to opinions and suggestions. Indeed, this plan was largely successful

This type of implementation contributed to the development of the technical capabilities of the staff of Baghdad Women Association, as they had experience in using these sites, and thus this evolved to be represented by holding seminars and weekly and monthly meetings.


In addition to sharing stories, safe lines, suggestions and recommendations, all via electronic platforms, not only this, but also continuing to provide health instructions for the prevention of the virus represented in written and visual instructions.

With the increase in cases of domestic violence during that period, the role of Baghdad Women Association became greater, and it had to continue in communicating with women and girls through safe lines to provide psychological and legal support and receive and refer cases.

In the presence of the virus the work was and still requires more effort, but the successful results are the fruit of that effort.

Case management survivors of violence of women and girls during the Corona pandemic

Of course, violence against women and girls increases in times of emergency and crises for several factors, most notably psychological stress, the disintegration of social protection systems and the financial stumbling of families This is what happened during the Corona pandemic and the closures of most state institutions and the home quarantine, which led to an increase in cases of violence, specifically domestic violence against women and girls, due to the deterioration of the living conditions that most people live in from poverty,









unemployment, economic pressures, restricting the movement of people and staying for long periods in homes. All this has turned homes into a very dangerous place for victims of domestic violence during the Corona pandemic

Baghdad Women Association continued to provide support to women and girls and follow up their cases, and relied on providing (remote case management) during the period of the outbreak of the Corona virus through its centres and following up on cases of gender-based violence and cases of high risk and threatened with suicide, with an emphasis on maintaining confidentiality, safety and security by providing safe lines designated for providing psychological, social and legal listening and counselling services for women by phone, distributed to each centre, through which cases are followed up by social workers to provide psychological support, activate legal referral services, psychological therapist, provide livelihoods, and a group of dignity kits that include sterilization and prevention needs through coordination with a group of organizations that provide different services to women and girls.

The association also continued to provide online awareness sessions on topics that touch the lives of women and girls and their problems, such as (increasing violence - dealing with quarantine - reproductive health - dealing with psychological stress - preventing the virus - dealing with people infected with the virus).

As well as providing training and vocational courses and social support sessions in the form of groups through social media programs to ensure continuity of communication and support between the association's centres and the target groups to achieve the goal we are working on, which is to reduce gender-based violence, empower women and girls and build their capacities.





Awareness videos have also been designed to be published on the association's official page urging adherence to preventive measures to reduce and mitigate infections with the virus, in addition to statistics that show the rates of increased violence against women and girls.

Data Documentation / Baghdad Women Association

Baghdad Women Association relied on documenting data to demand the right to express injustice and lack of justice and to indicate that the victims, survivors and those concerned about them will not remain silent.

Rather, they adopted a strategy to expose these violations, acknowledge their existence, and challenge societal, political, and economic patterns to improve women's lives and change conditions that negatively affect their lives, families, or communities.

Also, seeking accuracy and sensitivity in telling and documenting women's stories may contribute to challenging discrimination within countries and societies, or violence committed by individuals.

The association seeks to build strong alliances among women, support and help survivors in recovery, and change national policies by condemning the perpetrators, to achieve the core objective of documenting the data, which includes Changing or enhancing the state's response to violations against women and increasing opportunities for positive communication with decision-makers and relevant local and governmental authorities.







Documentation results

- Draw patterns of violations over a certain period of time, or against a specific group.
- A more comprehensive understanding of the circumstances of the occurrence of violations and the establishment of an information base and statistical data.
- Assessing the extent of violations and their spread.
- Identify the perpetrators in a clear and specific manner.
- Follow up on the measures taken by the authorities to address the situation.
- Providing evidence about specific violations without disclosing witnesses and sources.

In order to facilitate the exchange of documents and to provide the opportunity for a number of people to view them at the same time, Baghdad Women Association used electronic documentation, as it works to create a safe environment for dealing through social media and the Internet, as the global community began to move towards the use of electronic means because of its valuable benefits to society, and therefore the association adopted to publish press releases for all activities carried out, trainings and meetings, in addition to the monthly and annual statistics of the social and legal listening and counselling centres for women and girls who are survivors of violence, which show the number of women exposed to violence, their ages and the type of violence in addition to the type of services provided to them.






Opening Baghdad Women Association centres

Opening a new Psychological and Social Listening and Counselling Centre in Mosul

Baghdad Women Association inaugurated its new centre for social and psychological listening and counselling for women and girls in Mosul governorate - Almasarif district within Promote Economic and Social Empowerment, Dignity, Well-being and Safety for Survivors of Sexual Violence during conflict promote economic and social empowerment, dignity, luxury and Safety for Survivors of Sexual Violence during Conflicts funded by Norwegian People's Aid on January 26, 2020.








Opening a new Psychosocial and Legal Listening and Counseling Centre in Anbar

Baghdad Women Association conference on the occasion of International Women's Day


Baghdad Women Association held a conference on the occasion of International Women's Day entitled (Women's Political Participation in Iraq - Opportunities and Challenges) with the support of UN Women on March 10, 2020.

The theme of International Women's Day (8 March 2020) comes under the slogan "I am the Generation of Equality: Realizing Women's Rights" within the framework of the new multi-generational campaign of UN Women, Generation Equality, which comes on the occasion of the 25th anniversary of the adoption of the Beijing Declaration and Platform for Action, which adopted in 1995 at the Fourth World Conference on Women in Beijing, China, as the most advanced roadmap for empowering women and girls everywhere.

The year 2020 is a pivotal year for the advancement of gender equality around the world, as the global community is assessing the progress made on the field of women's rights since the adoption of the Beijing Platform for Action. It will also witness several moments in the gender equality movement: five years since the Sustainable Development Goals were announced; the 20th Anniversary of Security Council Resolution 1325 on Women, Peace and Security and the 10th Anniversary of the Founding of UN Women.

The conference was attended by His Excellency the Canadian Ambassador in Iraq, the representative of the Swedish Embassy in Iraq, the representative of the French Embassy in Iraq, in addition to the presence of the United Nations Women in Iraq. the conference was also distinguished by the attendance of more than 120 personalities (civil society organizations, human rights activists,








media) in addition to the presence of members of the Independent High Electoral Commission.

The conference was opened with a welcome by the conference presenter, Mrs. Anwar Al-Rubaie, then the national anthem was played, and then the speech of Baghdad Women Association was given by Mrs. Batool Hussein, and then the first session of the conference was opened, which was represented by the presentation of three research papers, which are the current challenges that impede the participation and representation of women in the decision-making process was presented by Dr. Faten Al-Halfi / member of the Human Rights Commission, and the legal framework that governs the political participation of women presented by the lawyer Tameem Al-Azzawi and the role of women in the democratic transition in Iraq presented by Professor Khalil Ibrahim / researcher in the field of human rights. In the second session the discussion was conducted in focused work groups by the participants in order to extract recommendations.

The conference came out with many recommendations, the most important of which are:

- 1. Intensifying the capacity building programs for women in management and leadership.
- 2. Continuing the advocacy campaigns led by civil society organizations towards amending legal legislation that serves women.
- 3. Comprehensive social awareness of women's political rights.
- 4. Stand against the withdrawal of custody from the mother.
- 5. Economic empowerment of women as it is a source of strength for them to face family and social challenges.









- 6. Amending laws relating to women's political participation to ensure broader and more effective political participation.
- 7. Expanding the percentage of women's participation in the legislative authority to more than 25%.
- 8. Reducing the tribal ideology that restricts women's participation.

At the end of the conference, ten women activists who made their mark in partnership with the programs of Baghdad Women Association were honored, and then the bazaar was opened to display the products and works of women and girls.


The National Civil Society Conference






Symposium of the 16th anniversary of Baghdad Women Association establishment


















Feminist Forum in the Middle East and North Africa for Peace Advocates






The supplementary consultative meeting to discuss the second Iraqi national action plan for UN Security Council Resolution 1325










Recommendations and suggestions

Recommendations and suggestions for the year 2020 By the staff of Baghdad Women Association to the administration of Baghdad Women Association, donors, local partners and civil society organizations

- ✓ Paying attention to the segment of volunteers and allocating work wages to appreciate their efforts.
- ✓ Supporting small economic projects for women because of their effective role in changing their lives after their prosperity and development.
- ✓ Providing a legal support service in all the centres of Baghdad Women Association that provides legal consultation and performs judicial representation in the courts for free, as well as a psychological treatment service with a specialized psychological therapist.
- ✓ Conducting an evaluation of the target areas of the project to assess the needs of the target groups and focus on achieving the needs in the project plan.
- ✓ Adding health services for women and children in the centres of Baghdad Women Association.
- ✓ Expanding the circle of work and covering wider areas within Al-Anbar Governorate, due to the region's need for awareness and support, and the continuation of providing economic empowerment to women within the governorate, as well as the continuation of providing legal support and consultations.
- ✓ Distribution of the health kits of families due to the lack of support from other organizations.










- ✓ Paying attention to the effective role of women within the family by involving family members as well in violence reduction programs, not just women.
- ✓ Involve men and boys in the plans of advancing the situation of women, especially in terms of gender-based violence
- ✓ Before starting to write any project related to a specific area, it is better to conduct a needs assessment for women and girls before that, so that the activities are appropriate to their needs and capabilities
- ✓ Providing some activities to educate adolescent girls
- ✓ Implementing programs for people with special needs because they are the most marginalized group in society
- ✓ Spatial expanding of the work to include the rest of the southern governorates.
- ✓ Building the capacities of employees in ministries in monitoring and evaluation tools, and writing reports.
- ✓ Continuing pressure on decision-makers to pass legislation that provides a safe environment for women at the family, work, and community levels.
- ✓ Continuing the activities of raising social awareness, since the awareness of the majority towards women's rights is below the required level.
- ✓ Planning project activities in a way that affects and changes the hostile social behaviour towards females, and not work in order to work only, but in order to change.
- ✓ Expand networking and coordination with civil society and the media in order to create a public opinion that supports women's issues and not to be closed to the administrative and formal contexts of government







institutions, which usually narrow the scope of work and limit participation.


